A sturdy, wooden board with a dedicated storage compartment for convenient, organized use in your outdoor kitchen.



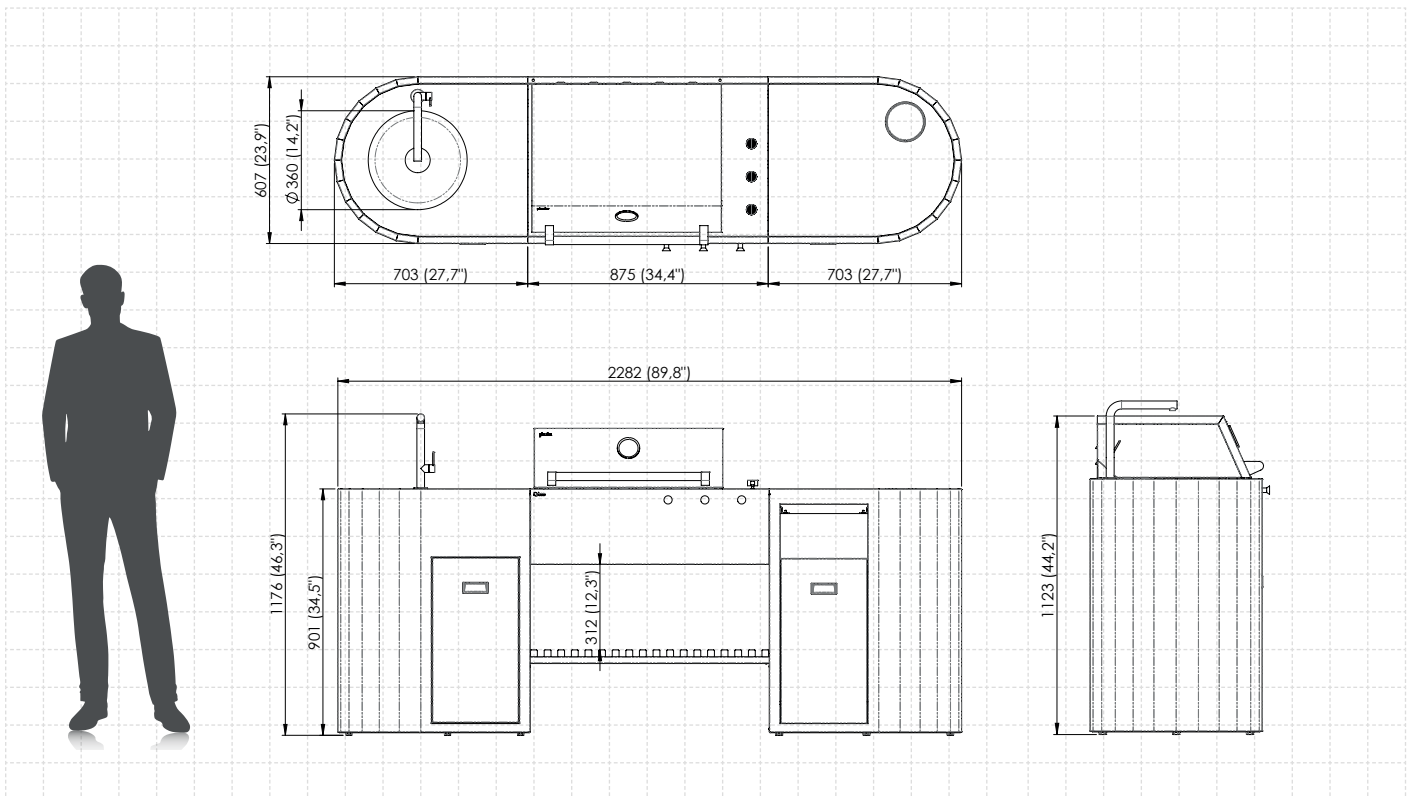

## **8. Returns & Cancellations**

8.1. Due to the nature of the Products, returns are not accepted, except in cases of manufacturing defects confirmed by the Manufacturer.

## **9. Warranty**

**9.1.** The Manufacturer provides a limited warranty covering material and manufacturing defects of the Ovo Compact Kitchens and their components, according to the following structure:

### **Grill Unit**

#### *Stainless Steel Covers*

Warranty period: 5 years

The warranty covers material and manufacturing defects of covers made of stainless steel.

#### *Stainless Steel Grates*

Warranty period: 5 years

The warranty covers material and manufacturing defects of stainless steel grates.

#### *Other Grill Components*

Warranty period: 2 years

The warranty applies to all remaining components and parts of the grill not specified above.

## **Kitchen Structure (non-grill elements)**

### *Kitchen Housing / Cabinet Structure*

Warranty period: 2 years

The warranty covers material and manufacturing defects of the kitchen body and structural components.

### **Cosentino Stone Surfaces**

Manufacturer's warranty period: 2 years

The Manufacturer provides a 2-year warranty covering material and manufacturing defects. Additional warranty coverage of up to 25 years may be granted directly by Cosentino, subject to product registration and in accordance with Cosentino's own warranty terms and conditions.

9.2. The warranty period is calculated from the date of sale of the product to the end customer, as indicated on the sales invoice.

9.3. The warranty does not cover defects or damage resulting from:

- improper installation or use inconsistent with the user manual,
- mechanical damage, misuse, neglect, or unauthorized modifications,
- normal wear and tear,
- damage caused by external factors or force majeure.

9.4. Warranty claims must be submitted in accordance with the Manufacturer's official service and complaint procedure and must be supported by proof of purchase and appropriate documentation.

## **10. Complaints & After-Sales Service**

10.1. In case of a service issue, defect, or warranty claim, the Customer should contact the Seller by email.

10.2. The service request should include:

- proof of purchase,
- product model and serial number (if applicable),
- description of the issue,
- photographic or video documentation, where possible.

10.3. The Seller will confirm receipt of the service request and process it in accordance with applicable EU consumer law.

## **11. Liability**

10.1. The Manufacturer is not liable for indirect or consequential damages, loss of profit, or business interruption.

10.2. The Buyer is responsible for ensuring compliance with local regulations, consumer law, and installation requirements in the country of sale.

## **11. Governing Law & Jurisdiction**

11.1. These Terms are governed by the laws of Poland, including the Polish Civil Code.

11.2. Any disputes shall be settled by the competent courts in Poland, unless otherwise agreed.

## **12. Final Provisions**

12.1. These Terms constitute the entire agreement for the sale of Ovo Compact Kitchens and supersede any prior arrangements related to this product line.

12.2. If any provision is deemed invalid, the remaining provisions remain in full force.

12.3. The Manufacturer reserves the right to amend these Terms with prior notice.
